

USSSA Youth Slow Pitch World Tournament - West

Congratulations on an outstanding season and welcome to the 2019 USSSA Youth Slow Pitch World Tournament West. The tournament will be played in Clovis, New Mexico hosted by Guy Leeder Softball Complex, July 19 to July 21, 2019.

The USSSA Softball program will use pool play and double elimination format in its World Tournaments. Recreation Divisions will be offered in each of the following Age Groups:

The tournament entry fee is \$300. All entry fees must be paid online at www.USSSA.com.

Please follow these procedures to complete your entry into the tournament.

ENTRY PROCEDURE

All teams must be marked "qualified" on the www.USSSA.com site by their state director. To qualify for this event, all teams must be properly registered for the current year and must complete all local, state, divisional, regional and National tournament qualification requirements as administered by their respective USSSA Area and State Directors. Team entry form must be received by your USSSA State Director by Tuesday, July 9, 2019. For a listing of USSSA State Directors, visit the USSSA website at www.USSSA.com. State Directors must email or fax all required forms to Tournament Headquarters by Wednesday, July 12, 2019. State Directors must confirm the entries of all teams from their respective states into this World Tournament through the online berth approval process. State Directors must also insure that each team's frozen and approved roster is entered online at USSSA.com. THIS IS MANDATORY!

TOURNAMENT ENTRY CONFIRMATION

Teams may confirm they have been entered into the tournament by checking the USSSA website at USSSA.com. If your team is not on the website by Friday, July 12, 2019 at **3 PM EST, CALL YOUR STATE DIRECTOR IMMEDIATELY.**

ROSTERS

Each team's qualified frozen and approved roster must be posted on the USSSA website at www.USSSA.com. Changes may only be made in accordance with USSSA eligibility rules in Article III, Section 9 of the Official USSSA By-Laws. Contact your State Director for assistance. PLEASE DO NOT CALL THE TOURNAMENT DIRECTOR OR USSSA NATIONAL HEADQUARTERS REGARDING ROSTER CHANGES!!!

All players participating in USSSA Youth Slow Pitch program shall have proof of age (birth certificate) available at all times. Failure to have identification will result in disciplinary action as described in the USSSA Rule Book being applied. The offending team loses the game, is ejected from the tournament, placed last in the standings and forfeits all awards, sponsors travel money and tournament berths that would have been awarded at the tournament.

All teams are required to have a representative in attendance. The official schedule, tournament rules and information for teams will be distributed at that time.

Balls:

Hit your own USSSA Tournament approved softballs for the entire championships. Will have them for sale at the meeting.

BAT INSPECTION

Teams must have their bats ready to be inspected and approved for play prior to each tournament game.

Uniform Requirements:

In accordance with the USSSA Slow Pitch By-Laws, all teams must wear similar uniforms. This includes the same color and style jerseys, with or without the team sponsor's name. Long pants and/or shorts may be worn. Leggings, when worn, must be similar on all team members. Caps/visors are optional; however, when worn, they must be similar. In all programs non-duplicating numbers will be required at World Tournaments. The numbers must be a minimum of 3 inches in size and clearly visible. See Article V, Sec. 8c.

Uniform violations are not grounds for protest.

PROTEST PROCEDURE

The protest fee is \$100 cash. In case of an eligibility protest, the protest fee will be \$100 cash per player. The fee shall be returned if the protest is upheld.
